LIFETIME AWARDS

DEADLINE AUG 15 FOR 2015 AWARDS

GITCA members need to apply for Lifetime Awards (Stud Dog, Brood Bitch, and Versatility) by August 15th in order for their dog to be recognized at this year's banquet. Log in on this page.

The Stud Dog or Brood Bitch Lifetime Awards are presented to dogs or bitches that have 5 progeny who have earned AKC Conformation Championships regardless of whether the Stud Dog or Brood Bitch has a Championship themselves. The offspring do not have to be owned by GITCA members.

There are 3 possible levels of Versatility Awards: Junior, Senior, and Master. Junior Versatility is for dogs with titles in 2 sports, Senior Versatility requires 3 sports with 1 title in an advanced level. The pinnacle is Master Versatility where a dog must have earned titles in either 4 sports including 3 advanced levels or 5 sports including 2 advanced levels; one of those titles must be in the terrier sport of Earthdog.
